





# 4nd race LE PETIT ABERGEMENT

# \* supplementary regulations \*

#### Article 1: Definition

The Union Motocycliste de l'Ain (membership no.: 0053) organized on 21 and 22 July 2018 the 4nd race aside Le Petit Abergement 01260.

This competition will be organised in accordance with the requirements of the FIM and FFM sporting Code, the RTS hillclimbing and the regulations of the Championships of France and Europe 2018.

This event of the Championship of Europe and the 3° round of the Championship of France of the montagne 2018 is registered in the sporting calendar of the Fédération Française de Motocyclisme under no 696.

The length of the trail is 2500 m, the average width of the track is 6 meters.

The race side of Petit-Abergement hosts the Championship Switzerland and «Swiss motorcycle Legend Trophy». This event will count for the Championship of League Auvergne Rhône-Alpes mountain. (regulation on the website of the League (www.lmaura.org)

It will run over two days

### Article 2: competitors and machines

This event is open to drivers holding of a national 'NCO, NCP, NPH, LJA1' licence issued by the FFM for the year 2018 or licensed FIM Europe 2018) Only one person is allowed by machine with the exception of sidecars which the passenger must also be licensed.

LJA1 licence is issued on the FFM site (www.ffmoto.org).

Machines must meet the specifications of the FFM and FIM Europe technical regulations.

The same machine will not be able to be used by multiple drivers.

The sound level of the machines must be less than 102 dB.

## **Article 3:** Categories

The categories are those laid down in the European Championship of the mountain 2018 and a former non-Championship category and the Championship of France.

#### Article 4: Commitment

Entry fees are those provided for in the regulations of the 2018 French Mountain Championship, ie 150E, except for 25 power / quad 105E and 125E for the Promotion category.

The maximum number of entries will be 200. Priority will be given to drivers participating in the French Championship, until 21 June 2018.

The Commitment fees are those provided for in the rules of the Championship of France of the mountain 2018

The commitments applications will be accepted only accompanied by the entry fee by cheque or bank transfer (mandatory for foreigners).

21-06-2018 date entry fees will be increased according to the regulations of the Championship of France of the mountain 2018 the amount of the commitments will be cashed to the week after the event.

Competitors holding a license LJA1 and NCO (primo licensee) may participate in the categories Promotion. To these amounts, it should be added, the cost of the license LJA1 (Any event 1 day  $\le$  60  $\le$  taken on the site FFM (ffmoto.org) or  $\le$  70 taken on the spot during the administrative checks. (A medical certificate of less than one year is required to obtain this license).

By the mere fact of his commitment, the competitor declares that he is familiar with the present rules and agrees to comply with them in all his provisions.

**Article 5:** Confirmation of commitment

The allowed competitors will receive a confirmation of commitment that they must present during administrative control. The organizers reserve the right to refuse a candidate. In this case where this decision would be taken in the interests of discipline, the cheque for the amount of the commitment will then be destroyed.

**Article 6:** Refund of the entry fee will not be refunded on proof of absence addressed to the organiser by registered mail at least fourteen (14) days prior to the start of the event.

In addition, if reason of force majeure, the event could take place, (amenities and (or) permissions granted or withdrawn, disturbance of public order, financial defection), organizers would be liable to competitors than paid amounts. In all cases, participants could qualify for compensation.

Article 7: Testing

Any driver who will be taken in the coast the previous days the test with a machine not consistent with road or in violation of this code, will be sanctioned by the Board.

**Article 8:** Competitors

The welcome of the competitors will take place at Petit Abergement 01260 Haut Valromey, on Thursday, July 19th from 2pm. Runners' parks with showers and toilets will be open from Friday 20 July at 8 am.

Pilots will be placed in the park by members of the organization.

Pilots who arrive at night will be placed in the morning by these people.

Article 9: Administrative controls

They will take place on Friday, July 20th from 2pm. Verification operations will end on Friday, July 20 at

19:30 maximum and will continue on Saturday 21 from 7:30 to 10:00. The competitors must present themselves with their confirmation of commitment to administrative checks,

possession of the following original administrative documents • confirmation of their commitment • annual

licence or licence 1 event ("LJA1" permits will be issued by connecting to the site of the MFF: www.ffmoto.org.)

At the end of input, click "finish my application for licence", you must print it, date, sign it. You will find attached

to the licence a medical certificate completed by your doctor.

• parental consent for minor competitors IMPORTANT: the absence of one of these documents will be able to

compel the organizers to refuse the departure of the competitor, although it may claim reimbursement of its

commitment or a any compensation.

The Organizer will provide competitors a folder of the event including:

control technical sheet

the time and place provided for mandatory briefing

• information (phone PC, showers, container of polluting materials, etc.)

Article 10: Controls Techniques

Immediately after administrative control pilots will come to scrutineering with their machine equipped with:

technical control sheet

their complete equipment

of their soil and their fire extinguisher (1 per support vehicle) protection technical audit operations will

end Friday 20 July to 20 h00 maximum and will continue Saturday, 21rd from 7:30 to 10:00.

Controls sound level meter will be systematically carried out by the Scrutineers.

At the end of the technical control, they will be issued a transponder against a deposit in an amount of €200

cheque.

Transponders brackets can be purchased from the transponder head at the price of €10.

Transponders must be installed vertically by the pilots on the fork of the bike or the level of the front wheel for

sidecars.

Article 11: Route

Article 12: Ranking

The Championship of France of the mountain 2018 will be made according to the rules of it.

Article 13: Claims

The claims shall be made according to the rules of the Championship of France and Europe of the 2018

mountain.

Article 14: Safety device

The provisions implemented in order to ensure the safety and protection of the participants and third parties

are those specified in additional technical rules and safety articles discipline race aside.

Article 15: Medicalization

1 doctor, 2 ambulances and 4 rescuers will ensure the medicalization of the test. The nearest hospital is located

40 minutes by road in OYONNAX.

Article 16: Visa

insurance the event included in the calendar of the MFF and the FIM European is insured, in accordance with

the legislation in force, by R.C. No. policy underwritten Gras Savoye. In addition, it is recalled that each driver

can purchase a warranty insurance Personal Accident, as indicated on the last part of the guide of the licensee

2018 (application for licence FFM).

**Article 17:** Environment

each driver will be informed by display indicating areas of containers bins, sorting and recovery of waste oils and
